### **ORDER**

**UPON** the application of the Solicitors for the 1<sup>st</sup> and 2<sup>nd</sup> Plaintiffs by way of Summons filed herein on 17<sup>th</sup> February 2025 (the "Summons")

**AND UPON** reading the Affidavit of Sit Kien Ping Peter filed herein on 17<sup>th</sup> February 2025 and together with the exhibits referred to therein and the Affirmation of Service of Wong Ying Hong Andrew filed herein on 24<sup>th</sup> February 2025

**AND UPON** hearing the Solicitors for the 1<sup>st</sup> Plaintiff, and the representative of the 2<sup>nd</sup> Plaintiff, and the Defendant being absent

#### IT IS ORDERED that:-

- 1. Until further order of the court or the conclusion of the present proceedings, the Defendant must not, whether by herself or her servants or agents or otherwise, without the prior instructions or consent in writing of the 1<sup>st</sup> and 2<sup>nd</sup> Plaintiffs:-
  - (a) enter, occupy or remain at or in any way trespass, cause or permit trespass into the Plaintiffs' office situated at 25A United Centre, 95 Queensway, Admiralty, Hong Kong (coloured pink in the floor plan annexed in Annex 1 herewith) (the

"Office") or the lift lobby on 25/F., United Centre, Admiralty, Hong Kong (coloured yellow in the floor plan annexed in Annex 1 herewith) (the "Lift Lobby") without having obtained the prior permission of the authorized representative of the 1<sup>st</sup> and 2<sup>nd</sup> Plaintiffs; or

(b) cause or permit nuisance to any of the Office or the Lift Lobby and to the partners, licensees, lawful visitors of the Plaintiffs and/or their employees or representatives working in the Office or the Lift Lobby. The acts to be restrained include but are not limited to (i) interfering with the quiet occupation, use and enjoyment of the Premises by the Plaintiffs and their partners, licensees, lawful visitors and/or employees or representatives; (ii) hindering, obstructing or preventing access to or egress from any of the entrances of or within the Office or the Lift Lobby; (iii) displaying notices, banners, placards or posters in the Office or the Lift Lobby; and (iv) using loudspeaker or any other similar broadcasting devices;


- 2. There be liberty to apply; and
